The **Kentucky Board of Licensure for Massage Therapy** will meet on **June 7, 2021**, at **1:00 p.m. EST** by live audio or live video teleconference pursuant to the Kentucky Open Meetings Act, KRS 61.800, *et seq.*, Senate Bill 150, and Executive Order 2020-243 in response to the COVID-19 state of emergency.
